## Frequently Asked Questions

#### When and where is the 2023 NNFA/NALA Innovation Summit?

Summit is Sept. 18-19 at Nebraska Innovation Campus, 2021 Transformation Dr., Lincoln, Neb.

## Is there a virtual option?

Summit will be in-person only.

## When is the registration deadline?

Pre-registration is encouraged. Walk-in registrations will be accepted if space allows.

## How many continuing education hours (CEs) can I earn?

Receive up to 8.75 hours by attending both days of Innovation Summit.

## How do I earn CEs and receive my certificate?

You must complete an evaluation for each session you attend to receive a certificate. To access evaluations, <u>log into your member account</u>, click My Account at the top of the page, then click on the My Participation tab. Evaluations will be linked under "Events Eligible for Certificate."

More information on the certificate process will be emailed to attendees prior to the event and staff will be on hand to help with completing evaluations on site.

Participants must stay in the education session the entire time to receive full credit.

## Do I need to register for each session I would like to attend?

Pre-selection of the sessions you plan to attend is encouraged. You must select the sessions you attend on your member account to receive your certificate of completion following Summit.

You may add or edit your selections on your member account at any time. To view or edit an existing registration, log into your member account, click My Account at the top of the page, click on the My Participation tab, then click the <u>Innovation Summit | Forces of Change: The Future of Work</u> link under Events Registered For.

## Do I need to attend all days?

One and two-day registration options are available.

## Can I attend the Membership Meeting although I am not attending Summit?

Yes. Please check in at the registration desk inside the main entrance when you arrive.

#### How do I access handouts?

Handouts will be made available on the NHCA app and on your member account at nehca.org. To access, log in and click My Account at the top of the page, then click on the My Participation tab, then click the <u>Innovation Summit</u> | Forces of Change: The Future of Work link under Events Registered For.

## Will there be a trade show?

Summit will not include a traditional trade show, but vendor displays will be set within the banquet hall and main hallways throughout the day on Tuesday. #### **Parking**

Parking is available in the <u>paved lot north of Transformation Drive</u>. Payment is required at \$1.25/hour or \$6.00/day. Use the Passport Parking app (**Zone 9900**) to pay for parking. Please note the app doesn't accept payment until 8:00 a.m. Paid parking will be enforced from 8:00 a.m. to 6:00 p.m.

**Note:** Pay stations at Nebraska Innovation Campus are for on-street metered parking payments only. Pay stations cannot be used to pay for parking payments for vehicles parking in the paved lot north of Transformation Drive.

Use the Passport Parking app (Zone 9900) to register your vehicle.

- 1. Download the Passport Parking app from the Apple App Store or Google Play store.
- 2. Create an account with your mobile phone number or email address.
- 3. Park anywhere you see Passport Parking app signs and decals.
- 4. Pay for your parking session from your phone using Zone 9900.
- 5. You may extend your time remotely through the app.
